Every nomination paper must be submitted in the **Form B** and **Form C** giving the details and consent required therein.


Nomination papers in respect of which provisions have not been complied with or which are not received by the Returning Officer by the aforesaid date, will be considered invalid.

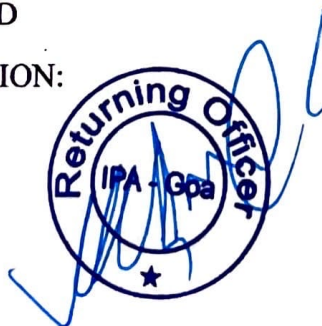
